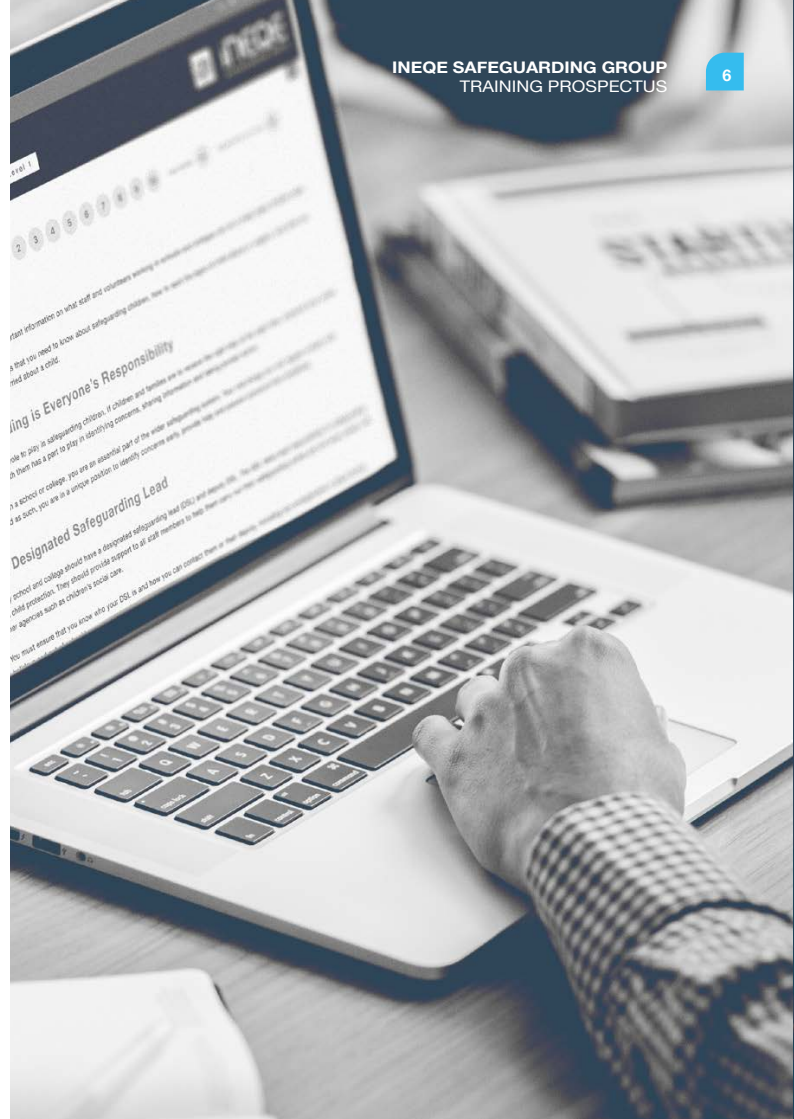

# SSNAP CARDS WORKSHOP

---

The **SSNAP (Safer Social Networking Activity Pack)** workshop is an interactive learning experience which provides an insight into the way young people engage and interact with social media. Through the use of physical cards, participants learn how to identify and mitigate risks.

The scenarios depicted in the cards are informed by real safeguarding incidents, case studies and learning reviews. They provide a context for behaviour on these platforms, including their use, application and potential consequences, with a focus on geolocation, anonymity, encryption and harmful behaviours.

Safeguarding professionals will receive relevant and credible insight into the challenges and opportunities they will face when safeguarding in a digital world. This course is designed to enable participants to apply what they have learnt across their organisation.

# SAFEGUARDING TRAINING

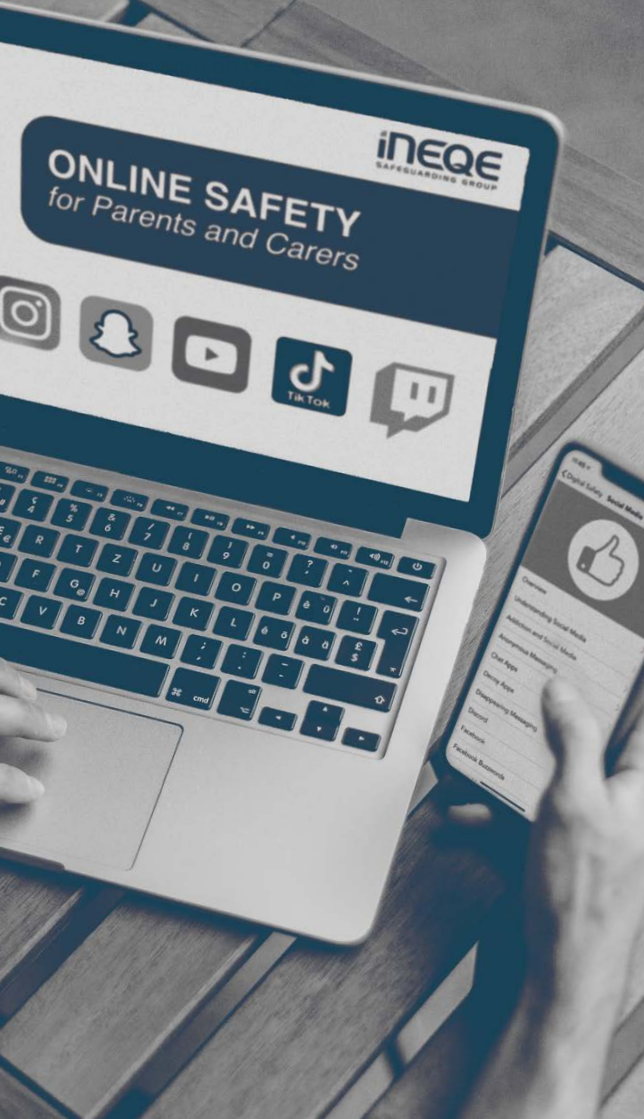
## Who is the training for?

A whole-school approach to online safety means we provide tailored learning for safeguarding professionals, school staff, teachers, parents, and carers along with age-appropriate advice and guidance for students.

## Why is it useful?

Our training for school communities helps to develop resilience, confidence in pathways for help against online harms and promotes an active and collaborative learning environment where the whole school can flourish. Parents can learn independently and improve their communication skills in a co-learning approach with young people in their care.

Courses also cover 'good practice' tips for utilising virtual platforms and accessing online resources.





---

## SAFEGUARDING LEVEL 1

This basic course will help you learn how to recognise breaches of safety and abuse within school settings, how to make a referral to relevant safeguarding professionals, and how to escalate concerns according to best practice.

Learn how to recognise abuse, make a referral, share information and escalate concerns.

### Learning outcomes include:

- Refresh your knowledge of safeguarding and best practice for those who work with children and young people.
- Understand how to recognise abuse, make a referral, share information and escalate concerns.
- Gain an overview of context and how it has an impact on safeguarding both online and offline.

---

## SAFEGUARDING LEVEL 3

This advanced course is aimed at professionals with safeguarding responsibilities, such as managers, designated teachers, and safeguarding professionals.

Build your knowledge of current legal framework and established safeguarding processes, alongside the practical skills to handle disclosures, manage referrals, train staff, and work effectively with other agencies.

- Learn key lessons from safeguarding reviews on professional curiosity and thinking about context.
- Recognise how you can build in safeguarding practices to protect children and young people and signpost to further support.

This advanced course provides an insight into offending behaviour and in particular how predators use positions of trust to facilitate sexual abuse of children.

Insights from perpetrator interviews are used to help you learn about the tactics they employ to infiltrate vulnerable groups and the behaviours and defences they adopt when suspected or caught.

- Gain an insight into the way predators manipulate positions of trust to sexually abuse children.
- Awareness of the tactics perpetrators use both offline and online.

---

## SAFEGUARDING FOR GOVERNORS

A tailored introduction for school governors to understand their statutory duties and how to effectively deliver on their safeguarding responsibilities.

Includes a recap on the basics of safeguarding and best practice guidance on contextual safeguarding.

## MISSING, EXPLOITED, TRAFFICKED (MET)

Learn about the importance of 'safeguarding first', contextual safeguarding and professional curiosity in practice.

### Learning outcomes include:

- Understand indicators and risk factors for children and young people.
- Develop your safeguarding expertise with best practice advice for both the online and offline world.



---

## YOUTH PRODUCED SEXUAL IMAGERY (YPSI)

Learn how to navigate and understand youth produced sexual imagery, the risks and impacts involved in image sharing and your responsibilities as a safeguarding professional or volunteer.

### Learning outcomes include:

- Learn about the varying motivations behind YPSI.
- Understand the risks and impact of image sharing.
- Develop confidence in responding to incidents.

---

## SEXUAL AND GENDER-BASED VIOLENCE (SGBV)

Understand, identify and report safeguarding concerns on issues of sexual and gender-based violence including FGM, domestic abuse, sexual assault and sexualised bullying.

### Learning outcomes include:

- Learn about the cultural and societal issues surrounding SGBV, including school-based settings.
- Develop confidence in identifying issues related to SGBV.
- Understand best practice in relation to addressing these issues.

---

## **SAFEGUARDING POLICY, AUDIT & SELF ASSESSMENT DEVELOPMENT**

This course considers the key elements required in a good safeguarding children policy, the importance of law/regulation, good practice and organisational context. It also provides an overview of the key elements required to deliver quality safeguarding audits or self assessments.

---

## **SCHOOL COMMUNITY TRAINING PACKAGE**

Designed with Ofsted or independent inspection in mind, the training provides schools with an overview of contemporary safeguarding issues both online and offline for teachers, staff, students, parents and carers.

Increase your knowledge on safety settings, parental controls, online risks, and the operational support available to parents and carers online.

---

## **CONSENT**

This training gives a clear, practical and age-appropriate explanation of sexual consent, self-esteem, bodily integrity and respect.

## **ADDICTION IN A DIGITAL WORLD**

# AN INTRODUCTION TO...

---

## SOCIAL MEDIA 101

Professionals and parents tell us that they struggle to keep up with the ever-evolving trends of social media platforms. There is a need now more than ever to understand these platforms, as children and young people are spending an increasing amount of time online.

Participants will gain an in-depth understanding of the core functions of popular platforms and the risks associated with them.

### Learning outcomes include:

- Enhance your knowledge of the most popular social media platforms and their basic functions.
- Develop confidence in navigating the online cultures and communities, including social media and gaming.
- Understand the best way to keep children and young people safe on the apps and platforms they use.

## APPROPRIATE USE OF SOCIAL MEDIA

Learn about best practice in respect of online communication.

This includes how to protect both your organisation and your own professional reputation, as well as how to develop and maintain appropriate boundaries with young people, service users and their carers.

### Learning outcomes include:

- Gain a better understanding of the impact different actions can have on reputation.
- Learn about best practice in respect of online communication.
- Have an awareness of the law related to, and potential consequences, of a misuse of social media.



---

## DIGITAL COLLATERAL

Our digital collateral training provides an insight into the way young people engage and interact with social media. Delegates will explore what digital collateral is and consider scenarios inspired by real safeguarding incidents.

This training provides an insight into how self-generated or perpetrator-captured images can form a thread that is used to coercively control and manipulate young people.

Furthermore, this course provides tips on what to look for, how to react when dealing with an incident, and which potential reporting and support pathways will be helpful.

### Learning outcomes include:

- Gain an insight into the way young people engage and interact with social media.
- Explore what digital collateral is and consider scenarios.
- Understand what to look out for to protect young people from harm.

---

## COUNTY LINES (CRIMINAL EXPLOITATION)

The term ‘county lines’ refers to a complex phenomenon that is largely based around organised crime groups trafficking drugs across the country.

The issue includes significant safeguarding risks to children and young people who may be criminally or sexually exploited and exposed to risks from drugs, weapons, serious violence, modern slavery and trafficking.

This training gives you an introduction to the ‘county lines’ business model and advises you on how to recognise, report and respond to young people at risk from criminal exploitation.

### Learning outcomes include:

- Understand how young people can be exploited by gangs, particularly through the use of technology and social media.
- Recognise the signs of a child or young person being at risk of exploitation.
- Learn how to respond if you believe a child or young person is at significant risk to criminal exploitation.

# SAFEGUARDING IN FAITH COMMUNITIES

---

## YOUTH MINISTRY & THE DIGITAL WORLD

This training course explores the intersection of youth ministry and the digital world, equipping leaders with the knowledge and skills to navigate online risks, highlighting both the opportunities and the unique risks to faith settings. Learn how to identify and address online issues including grooming, cyberbullying, inappropriate content, privacy concerns, and social media's impact on mental health. Develop an understanding of the importance of policies that guide appropriate use of social media for those in such roles and learn about strategies to create safer online spaces, foster positive interactions, and utilise technology for effective youth ministry while adhering to safeguarding good practices.

### Learning outcomes include:

- **Identify online risks:** Grooming, cyberbullying, harmful content.
- **Establish healthy boundaries:** Professional conduct, separate accounts, appropriate content.
- **Utilise technology effectively:** Connect, engage, and foster spiritual growth.
- **Safeguard young people:** Prioritise online safety and protect faith formation.
- **Promote responsible tech use:** Encourage balance and digital well-being.



## RESPONDING TO THOSE WHO POSE RISK IN CHURCH SETTINGS

This course equips church officers to assess and manage risks posed by individuals, including those who have sexually harmed. Training covers implementing safety plans and emphasises the importance of communication, collaboration, monitoring procedures and enhancing knowledge of relevant policies for a safer church environment.

The course also addresses how some individuals that are considered to represent a risk may minimise, self-justify and blame others for their previous conduct. By incorporating scenarios and good practices, this training equips church officers with the necessary tools to prioritise the safety and wellbeing of all church members.



### Learning outcomes include:

- Implement, monitor, and apply effective safety plans.
- Understand and address concerning behaviours such as minimisation, justification and blame.
- Support the Church community, including the point of contact, while maintaining confidentiality.
